### 1. MEMBERSHIP FEES

a) Life member - active or supportive.....	\$ 450.00
b) Member for the year in progress:	
active.....	45.00
junior.....	45.00

18 years or over.....	30.00
less than 18 years.....	10.00

### 2. HORSE REGISTRATION FEES

When these regulations are implemented, fees payable to the Association for registration of horses shall be as follows:

### 3. GELDINGS OR CASTRATED MALE

1. If registered under the name of a paid member who was also at the time owner of the dam, or has purchased it from a member in good standing .....	35.00
2. If registered under the name of a person who is not a member of the Association, or after being purchased from a person who was not a member of the Association.....	65.00
3. If is more than thirty-six (36) months old.....	125.00

### 4. STUD, MARE OR FILLY

If registered under the name of a member in good standing who is or was the owner of lessee of the dam at time of birth and also a member in good standing in the year the dam was bred or after purchasing the animal from a member in good standing who also meets the afore-mentioned requirements:

If the horse is less than twelve (12) months old;	35.00
If the horse is at least twelve (12) months old but less than thirty-seven (37);	65.00
If the horse is thirty-seven (37) months old or more.	225.00

**To these fees, you may add the following amounts, if applicable:**

\$40.00 if the owner or the lessor of the dam is not or was not a member in good standing in the year of birth

\$40.00 if the owner or the lessor of the dam is not or was not a member in good standing in the year of breeding

\$35.00 if the applicant is not or was not the owner and/or a member in good standing in the year of application for registration and if this application is not made the same year as birth of the animal to be registered.

### 5. TRANSFER OF OWNERSHIP FEES:

1) From a paid member to another paid member:	
Within 60 days of sale.....	35.00
Beyond 60 days of date of sale .....	65.00
2) From a paid member to a non-member:	
Within 60 days of sale.....	65.00
Beyond 60 days of date of sale.....	80.00
3) From a suspended member or from a non-member:	
Within 60 days of sale.....	65.00
Beyond 60 days of date of sale .....	80.00
4) No transfer fee is charged if the horse was sold before being registered.
